

October 3, 2018 Meeting



Membership Chair Pat Flatt presented each of the five applicant's names and the letters of recommendation to the club. The club voted by separate ballots for each applicant. Tammy Anderson (Briscoe & Richardson), Betty Cure (Mary Lynn Martin, Hicks), Cynthia Gookins (Briscoe & Richardson), Janie Lewis (Hicks, Hoffman), and Kathy Preissinger (Schmidt & Eichler) were approved for membership and will join WWC November 7, 2018. Pat will send each one a letter welcoming them into membership.

Scholarship Chair Lori Kaspar was called out of the meeting on business and will present changes to the Scholarship Rules concerning dates at the next meeting.

Nancy Priddy announced changes to the March 13, 2019 Field Trip on page 25 of the Yearbook. The destination will be the Dallas Arboretum with the group meeting at 8:45 a.m. at the clubhouse to take a bus leaving at 9 a.m. and returning around 3:30 p.m. A \$20 charge covering the bus, entrance fee, and lunch at the DeGolyer House will be collected in February. Checks should be made to WWC.

Ways and Means Co-Chair Cathey Briscoe reported that the program is ready for the printer,

raffle tickets are ready, auction items are gathered, a "ladies luncheon" food service is being finalized, and table decorations are made. Diane Schumann reported that the tables were drawn today so that members now know their table number and name. Guests will check-in in the Tejas Room to receive their table number and name. There they can bid on the silent auction items as well. Diane thanked members for their cooperation and asked that she be called with any questions or for more tickets as a few are still available at this time.

Legislation and Federation Counselor Ernestine Shugart informed the club that Donna Hogue, Past Caprock District President, committed to fulfill one of the initiatives of the GFWC President to serve women in the military. Donna spoke at the GFWC Texas Fall Board Meeting in Austin where she committed to making 100-120 fleece throws as a part of the "Throws of Love" project for women on Texas military bases.

Ernestine reminded the club that Texas would host the GFWC Convention in June 29th to July 1, 2019. In conjunction with this, a flyer was distributed soliciting photos of iconic Texas scenes for use at the "Texas Night". Carolyn McLeod is in charge of this event and will be asking for our help.

Carolyn McLeod attended the GFWC Texas Fall Board Meeting and reported that amendments to By-Laws regarding a cyber club for

The assembly played games to get to know one another better and had presentations of information through a variety of methods. District Presidents presented 120 Dr. Seuss books that had been collected. Kathy Horak Smith serves as President of the District Presidents and introduced volunteer service tied to each Dr. Seuss book.

Ernestine encouraged all members to attend the GFWC Texas Pioneer District meeting Saturday, October 13th at De Cordova Bend Country Club. Host club will be The Nineteenth Century Club of Pilot Point. Everyone is to wear red to support the program, "The Heart Truth". Children's books will be collected to donate to the classrooms destroyed by Hurricane Harvey.

GFWC South Central Region Conference at the Sheraton, DFW Airport Hotel in Irving will be October 25-27, 2018. Information on this is in the latest issue of Texas Clubwoman magazine. She encourages everyone to attend these national meetings that are being held so close to us this year.

Cheryl dispensed with the Brag Can in order to conduct the drawing for the centerpieces and report on a new business agenda item.

President Cheryl Troxel reported that she is working with a new insurance broker to get bids for insurance on the clubhouse. WWC is being dropped by the current carrier leading to the revelation that the club has not been covered for clubhouse rentals or meetings by other groups. Cheryl will keep the club informed as progress is made on receiving insurance bids.

Ann Schmidt brought the dismissal prayer for education in our community.

Meeting adjourned at 2:45 p.m.
